Colorado Overview

- Secretary of State is Chief Elections Official
- Elected County Clerks are Election Administrators

Colorado Counties

- ❑ 64 Counties
- ❑ Highest voter registration:
Denver County – 452,361 Registered
- ❑ Lowest Voter Registration:
San Juan County – 663 Registered

Colorado consists of urban and rural environments and is geographically a mountains and plains state

Hart

- ❑ 70% of the Counties
- ❑ 25% of Colorado Voters
- ❑ 36% of the voting and tabulation equipment

Voting Equipment by Vendor

Premier

- ❑ 19% of the Counties
- ❑ 34% of Colorado Voters
- ❑ 22% of the voting and tabulation equipment

Voting Equipment by Vendor

Sequoia/Dominion

- ❑ 6% of the Counties and
- ❑ 26% of Colorado Voters
- ❑ 37% of the voting and tabulation equipment

Why a Uniform Voting System?

- End of equipment life
- Windows 2000 (63%)
- 2017 deadline for Risk Limiting Audit
- Mergers and vendor changes
- Support capacity by vendors

Why a Uniform Voting System?

- ❑ Staffing turnover
- ❑ Uniformity of service county to county
- ❑ Centralized support and printing capabilities
- ❑ Standardization of processes and policies, which protects voters, the State and counties

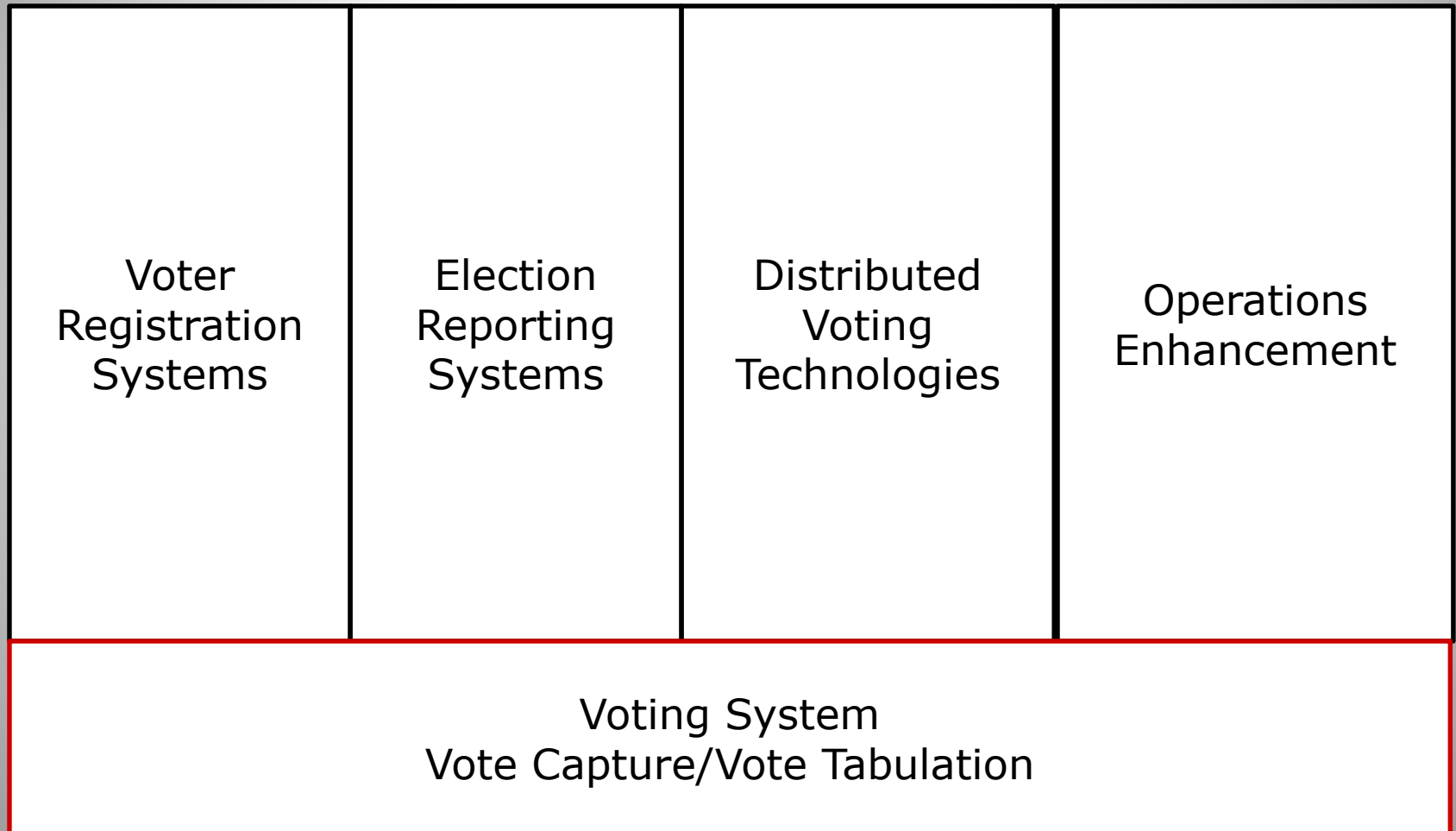
Title I Definition of Voting System

"Voting system" means a process of casting, recording, and tabulating votes using electromechanical or electronic devices or ballot cards and includes, but is not limited to, the procedures for casting and processing votes and the operating manuals, hardware, firmware, printouts, and software necessary to operate the voting system.

What is a “Uniform Voting System”?

The “Voting System” as statutorily defined is a major component of Colorado’s comprehensive election structure and must be considered in association with the other components of that structure. These include, but are not limited to, voter registration, manual and automated signature verification, accessibility requirements and programs, electronic pollbooks, ballot design and production, ballot on demand, electronic ballot issuing and reception for UOCAVA voters, statewide equipment and results auditing and election night reporting.

What is a “Uniform Voting System”?

- ❑ Ballot design and production
- ❑ Vote-capture and vote-tabulation
- ❑ Auxiliary components for accessible vote-capture processes
- ❑ Voter verifiable paper audit trail (VVPAT) production
- ❑ On-site close of polls report generation
- ❑ Ability to compile results from individual equipment components to central reporting system

What is a “Uniform Voting System”?

- ❑ Compilation and reporting of results in specific categories such as Early Vote, Absentee and Election Day
- ❑ Consistent procedures applied across all jurisdictions
- ❑ Defined roles for participants in the administration of elections
- ❑ Consistent formats for election data management
